K-8th grade and Preschool Tuition Payment Options

There are two options for tuition payment at Holy Trinity Catholic School.

1. Annual payment of entire tuition paid directly to the school by August 31st, 2017. Please note:
 - Families who make their annual payment on or before August 14th, 2017 will receive a 2% discount.
 - Families who do not make their annual payment on or before August 31st, 2017 will be required to sign up for one of the SMART Tuition payment plans below.
 - If you register for school after July 31st, 2017 and are using SMART Tuition then you will need to provide payment equal to two month's tuition directly to Holy Trinity with your registration fee and application. These tuition payments will be applied to your SMART Tuition account.

Families electing to make their tuition payments via SMART (who are not already enrolled), please note:

- A completed SMART Tuition confirmation page must be submitted with your Admission application
- There is a one-time per year \$50.00 administrative fee charged by SMART and it will be added to the first payment. Only one fee will be charged per family regardless of the number of students enrolled.
- The SMART payment methods are as follows:
 - ⓧ Automatic payment from bank account or via a credit card
 - ⓧ Online payment
 - ⓧ Payment by telephone
 - ⓧ Payment by mail (invoices will be sent instead of coupons)
- All families participating in SMART will receive invoices via email. Those who pay by mail will receive paper invoices as well.
- If your payment is not received by SMART on the due date, your account will be charged \$30.00.

SMART Payment Plans (Families with children enrolled in both Preschool and K-8 should choose one of the K-8 plans. See SMART form.)

Preschool -8th:

- ⓧ Monthly payments begin in July 2017 and extend through June 2018 (total of 12 payments) **(Plan M)**
- ⓧ Quarterly payments occur in: July, October, January, April **(Plan Q)**
- ⓧ Semi-annual payments occur in: July, January **(Plan S)**

Fundraising and Volunteering Fees (applies to K-8 only)

- Fundraising buyout payments are due separately from tuition and are payable directly to the school.
- The Fundraising Buyout amount of \$625 is due on or before October 1, 2017.
- The Volunteer Buyout amount of \$625 is due on or before December 3, 2017.
- Families that do not complete their fundraising and volunteer commitments will be invoiced for the remaining amounts with payment due by June 3, 2018. **Note:** Families of 8th grade students must make their payments before the date of the 8th grade trip for their child(ren) to attend. See the Tuition & Fees Agreement for additional details.
- A late fee of \$25 per month will be assessed with no grace period for all buyout payments and invoice payments for partially completed amounts.
- Payments for Fundraising and Volunteering Fees can be made directly to the school by check, cash, or money order.
